Mandatory update of mobile numbers, e-mail addresses and bank account details of the Account Holders of the Central Depository Systems (Pvt.) Limited (CDS')

The Securities Exchange Commission of Sri Lanka ('SEC), by way of Directive (Ref: SEC/DG/2022/02/35) dated 15"" February 2022, has made it **mandatory** for the CDS Account Holders to record/update their respective mobile numbers, email addresses and bank account details in the CDS with effect from 1" April 2022.

In our continuous effort to enhance security and accuracy of client information, the CDS issued the Circular number 02-03-2022 directing all Depository Participants to communicate with their clients/CDS account holders regarding the updating of their bank account numbers, email addresses, and mobile numbers.

Further to the above, the CDS hereby direct all Depository Participants to inform their clients/CDS account holders to mandatorily update their bank account numbers, email addresses, and mobile numbers in the CDS records by 30th September 2024.

Benefits of Updating Information:

- Enhanced Security: Updated contact information ensures that all communications, including transaction alerts and account statements, are sent to the correct email address and mobile number, thereby reducing the risk of fraud.
- Timely Notifications: With accurate email addresses and mobile numbers, clients will receive timely updates about their account activities, ensuring they remain informed about all transactions.
- Efficient Transactions: Updated bank account numbers will facilitate smoother and faster processing of financial transactions, including dividends and interest payments directly to the clients' given bank accounts.
